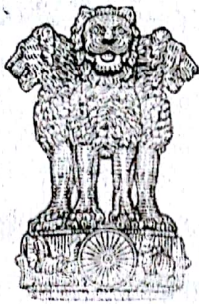

WHEREAS THE Author of the Trust possesses and absolutely owns cash which are valued at 11000/- (Rupees Eleven Thousand Only) and is desirous to establish a public charitable trust of the assets as aforesaid for the benefit of humanity at large.

AND WHEREAS each of the parties hereto of the "other part" has individually and jointly and has agreed to act as Trustees of the Trust, proposed by the party of the First Part.

AND WHEREAS the trust is hereby expressly declared to be a public charitable trust and all the provisions of this deed are to be construed accordingly.

AND WHEREAS it is necessary to declare the objects and terms of the public charitable trust, being constitutes under these presents.

NOW THIS DEED OF TRUST WITNESSETH AS FOLLOWS:

1. The name of the Trust shall be "KNOWLEDGE TREE FOUNDATION"
2. The principal office of the Trust shall be situated at Ranchi Road, Marar, Ramgarh Or such other place or places as the trustees may from time to time decide.
3. The Beneficiaries of the Trust shall be public at large.
4. The MAIN OBJECTS of the Trust are as follows :
 - a) To establish, run, maintain, support, assist or grant aid or other financial assistance to schools, colleges, libraries, laboratories, educational or other institution of the like in India, for use of the students and the staff and also for the development, advancement of education and diffusion of knowledge amongst public in general.

- b) To establish, run, maintain, support, assist or grant aid or other financial assistance to schools, colleges, libraries, laboratories, educational or other institution of the like in India, for coaching, guidance, counseling or vocational training or to grant individual scholarships for poor, deserving, downtrodden and needy students for elementary and higher education.
- c) To give financial or other assistance in kind by way of studentships, scholarships, stipends, medals, distribution of books, notebooks, clothes, uniforms, or meals for the poor and indigent at free of cost.
- d) To make the Rural/Urban masses self reliant, the trust shall establish or run Schools, Vocational Training Centers, Small and Cottage Industries, Handicrafts Centers, Bio-technology Development Centers, Software Parks, Typing/Computer Education & training Institutes under latest Information Technology Module etc.
- e) To uplift the Literacy in the people residing in India. To do this Trust shall run formal education, Vocational Training programmes of short and long duration long with distant Education Mode, organise Seminars, Debates, Meetings so that the Educational, self Reliant and Employment can be generated vigorously.

5. The OTHER OBJECTS of the Trust are as follows :

- a) To work environmental up gradation and make people aware of the ecological balanced of Nature on priority basis in view of alarming global environmental degradation.
- b) To Aid and establish, takeover or collaborate with any institution, school, ashram, or Association for Physical, Mental, Spiritual, Educational, Cultural, Moral Development & uplift of intelligence or its development.

- c) To promote Spiritual Students and open Spiritual Training & YOGA Centers for general public and to do everything to make spiritual studies popular amongst the public and also to provide for all activities for improving the moral standards of the people, promoting respect for all religions of tolerance and cordial feelings between man and man irrespective of status, caste and religion.
- d) To propagate, impart and adopt any audio-visual method for overall social, Cultural, Economical & Historical Awareness loving the social problems of crime, drug abuses and many other prevailing abuse and help in the inculcation of such behaviour as would bring happiness to the family of manor generally to making without reservation of his status, caste & religion.
- e) To work for creating awareness among the people against the hazards of population explosion in India.
- f) To assist in achieving the target of Health for all the Trust shall run programs in rural & urban areas and open the primary health centers, old aged relief & Shelter for disables, family welfare centers, Blood Donation Camp, Centers and Eye Care enters in the rural as well as urban areas, it shall also run centers for the drug addicts.
- g) To develop the awareness in the rural people towards environment. For this the trust shall make provisions for the drinking water, Clean Lavatory, Roads and undertake the social forestry in the rural areas and also run all the schemes as sponsored by Government and Non Government Institutions.
- h) To develop the awareness towards Culture in the people residing in rural areas. For this the trust shall open cultural Centers and stage Dramas, Music Programmes, Dance Programmes, meetings &

seminars of down trodden, young & new generations, etc. so that the cultural talent in the people of rural areas may be developed.

- i) To develop awareness in the farmers towards the high technology farming. For this the Trust shall run awareness programmes and assist the farmers in establishing the home scale/ small scale/ cottage industries/ agro based industries & marketing and storage of their produce.
- j) To receive and collect any Gifts, Subscriptions and Donation either in cash or in kind, or acquire by any other lawful ways and means and spend the same in fulfillment of all or any of the aims and object of the Trust. the income and properties of the trust shall be applied solely for the promotion and fulfillment of the aims and object of the trust, provide if any donor intends that his contributions donation or subscription shall be applied to the attainment of any particular objects or objects of the Trust, such Contribution, Donation Subscription shall be spent towards the promotion of that particular objects only.
- k) To acquire by purchase, take on lease, hire or by gift or otherwise and hold any movable or movable and also any immovable property or properties or any rights or privileges that may be deemed necessary or useful for the advancement of the objects.
- l) To do all such other lawful acts, deeds and things as per incidental and conducive to the alignment of the objects.
- m) to manage and administer any Orphanage, ashrams, Dairy Epeary, animal Birth Control Programmes, to work against cruelty of animals, Development of Handicraft & Handloom Programme, Waste Land Area Development Programme, Shelter for disables or Handicaps, nursing home, hospital, library, Reading Room, society School,

College, and other Institution irrespective of castes creed or social status.

- n) To take over, absorb or amalgamate with any other Trust or association or institution whose objects are similar to the objects of the Trust.
- o) To apply the income and properties of the trust for the fulfillment of its objects and to pay any portion there of by way of profit of dividend or bonus.
- p) Without prejudice to the generality of the above objects and for effectively carrying out the same the trust shall have power to receive, hold and possess any property including securities of any kind and to construct and maintain any building, manage, transfer or otherwise dispose of or deal in any property of security and to enter into any contract for or in connection with the purposes of the trust to raise moneys and funds for the benefit of the employees of the trust and to accept the management a of any trust or endowment on which the Trust mat be interested. The Trust shall have also the power to frame rules and bye-laws under its constitution.
- q) To make available the dwelling homes to scheduled castes and other destitute, run suitable programme.
- r) To assist the government programmes in its implementation and to run then with the help of the government.
- s) To help people during natural calamities and distribute the Food, shelter, cloth and Medicines free of cost.
- t) To sponsor programmes for release and rehabilitation of child laborers, women laborers and bonded and landless laborers etc.

- u) To accept any gift grants donations, contribution or subscription for the promotion of the trust and to issue appeal, applications for money and funds.
- v) To fulfill its objectives, the trust shall procure help from the government, non government, and other organizations within the country & abroad.
- w) To construct rural roads, culverts and bridge etc. for employment generation as well as comfort of travel to distance places, interior and hilly areas.
- x) To undertake any of the following activities :
- i. To publish pamphlets, journals, magazines, hold exhibition, seminars, scientific demonstration, research and study related to problems and rehabilitation of suffering masses.
 - ii. To provide and arrange fooding, lodging, health services, basic education & distribute basic teaching & learning materials to needy, Handicaps, orphans and other downtrodden.
 - iii. To establish psychological treatment system to control crimes in the societies, and intend to adopt the lining under social & creative life.
 - iv. To educate counsel women/ people against dowry system, problem of widows, and various other social evils as found in the societies and to provide livelihood and shelter to old & other handicaps, needy men & women.
 - v. To establish and run the hospital/ nursing home/ health centers etc. for treating and controlling the diseases like cancer, asthma. Aids, leprosy hepatitis-B, T.B., . And other dangerous diseases, and for

treatment & vaccination to apply homeopathy, unani ayurvedic & other traditional treatment systems also besides applying the updated research and development aid as being adopted these days.

- vi. To establish schools, libraries, institutions for training of security services and others.
 - vii. To promote and establish the centers of proper training.
 - viii. To promote the establishment the centers of proper training for sports & games like cricket, football, hockey, volley ball, basket ball, badminton, wrestling, athletics, gymnastics, rhythmic, swimming, table tennis, judo, yogic, physical exercises, karate, weight lifting, boxing lawn tennis, cyclic chess & other activities for upliftment of talent of youth, throughout the country and abroad.
6. The Trust may assist/donate to any other TRUST to carry out the various objects mentioned in the objects clause in such manner and to the extent the trustees may decide from time to time.
 7. The Trust may take on rent, hire, lease or in any manner whatsoever any movable or immovable property for the purpose of attainment of objects of the trust.
 8. The Trust shall be entitled to levy such fees, charges, subscriptions etc. as it may decide from time to time decide for the facilities to be provided at each of its projects for further development and upliftment and advancements of its object.
 9. All monies, which are not immediately required for the current needs shall be invested by the Trustees in eligible securities and investments, or in banks. Such investments shall be in the name of Trust or Trustees.

10. The Author of the trust shall also function as a member of the board of trustees.
11. The trustee shall stand possessed of the cash, here by conveyed and settled upon and shall use and apply the interest, the profits and the other income derived thereby for the purpose and object of the trust as aforesaid.
12. The cash hereby conveyed to the trustees shall form the corpus of the trust property, but the trustees shall have power from time to time to increase or decrease the corpus, according to best of their Judgment.
13. The Trust Shall be governed by a board of Trust-person as trustee as long as the total number of the trustees at any time does not exceed Eleven. In the event of death, incapacity insolvency, resignation or remaining trustees shall be entitled to nominate any other person as they think fit and proper to act as trustee in place of the trustee so dying, incapacitated, declared insolvent, resigning or refusing to act as such.

The administration of the trust hereby constitute and the entire control, supervision, regulation, management of the income and the profits there of as also of tall the donation and contributions and subscriptions, if any received by it shall vest in the uncontrolled discretion of the Board of Trustees subject however always to the provisions contained as hereinbefore.

16. The Board of trustees may frame rules and regulations for the administration of the trust and for carrying out the purpose and object there of and the same may be varied, altered, substituted or added to from time by a unanimous decision of the Board of Trustee with a view to introduce more effective administration and carrying out the purpose and the object of the trust. Such rules may specifically provide the basis or criterion of the selection of the beneficiaries although preference may be given in such selection to the people belonging to the scheduled castes or schedule tribes or down trod dens of other cast of the society.
17. The Board of trustees shall have power to accept donation from other in cash with our without any special conditions attached thereto PROVIDED that any such condition does not contravene the provision of clause 3, hereof. Subject to the same restriction, the board of constituted and declared.
18. The First Meeting of the Board of Trustees shall be held within three months of the date of the execution of this deed at such place and time as may be decided by the Trustees and in that meeting all relevant matters relating to the trust shall be considered in the all possible details and particularly the ways and manner to give effect to the provisions of the deed of trust and to attain the object and purpose of this trust. The trustee may induct such new trustees in the meeting as may be decided by them by majority of Votes as well as they may appoint CHAIRMAN of the Trust for such period as may be decided by them.
19. The trustees are hereby authorized and empowered to appoint a secretary to carry out the duties assigned to him in relation to the execution of this trust and to pay to him out of the trust fund such salary as the trustees for the time being may think fit. Even if any one of the trustees be appointed as the secretary he/she may be entitled to receive such remuneration/honorarium as may be decided by the Board or

Trustees. The trustees may appoint such staff as they deem expedient and necessary for the purposes of the trust at such salary as they may decided upon in each case.

20. The Board of Trustee may open Bank Account or Accounts in any Bank in the name of "Knowledge Tree Foundation", the account shall be opened and operated by such Trustee or Trustees as authorized by Board of Trustee.

21. The Trust may open bank account or Accounts in the name of Institution/Organization founded by the Trust. Such account shall be operated by such person as authorized by the Board of Trustees from time to time.

22. The trustees may in their uncontrolled discretion deposit for safe custody any documents or securities relating to or forming part of the trust property with the bank or banks as aforesaid on payment of such charges therefore, if any, as may be agreed upon and found expedient in the interest of the trust.

23. Meeting of Board of Trustees may be held at such time, at such place and on such dates as may be agreed upon by the trustees, Such meetings may be summoned by any one or more of the trustees by giving at least 21(twenty one) days notice in writing to all the trustees, specifying the year to consider and adopt the accounts of the trust hereby constituted and the report concerning those accounts as prepared by a Chartered Accountant after an audit thereof.

24. True and proper accounts of all the receipts and disbursements relating to the trust hereby constituted shall be kept by the trustees, the secretary thereof and/ or the employee (s) of the trust, who have been assigned the duty trust, who have been assigned the duty in that regard. On or after the 31st day of March each year, an income and expenditure

for the whole year up to that date and a Balance Sheet of the assets and liabilities as on that date relating to the affairs of the trust shall be prepared. These accounts and the balance sheet shall be duly audited and examined by a Chartered Accountant, which may be engaged by the Board of Trustees. For the purpose of such audit remuneration shall be fixed as they may deem necessary and desirable. As soon as may be after such audit, a meeting of the board of Trustees shall be held at which the accounts of the trust hereby constituted and the report of the auditor concerning the same shall be examined and adopted.

25. If the trustees differ with one another in respect of any such matter with reference to which they enjoy discretion, the opinion of the majority of the trustees present or voting at the meeting shall prevail and shall be binding on all the trustees, and in the event of the trustees being equally divided the view taken by the Chairman shall prevail in deciding such matter.

26. To carry out any other activity which is incidental to the attainment of the objectives of the Trust and within the parameters of the provisions of Income Tax Act, 1961 as amended from time to time.

30. The trust is not profit motivated.

31.No activity of the trust will be carried out outside India.

32.All the above objects shall be for the benefit of public at large without any distinction of caste, class, colour, creed, sex or religion.

33.That in the event of dissolution of trust properly, after meeting all liabilities shall be given or transferred to some other institution which is having similar aims and objects as may be determined by the Trustees.





